No. GHKH-192-2017-Parch-122017-1375-P.1:- WHEREAS the State Government is desirous to bring transparency and efficiency in Government delivery process for receipt of services, benefits or subsidies, that the beneficiaries use "Aadhaar number" as one of the identity document instead of producing multiple documents;

AND WHEREAS the farmers (hereinafter referred to as "the beneficiaries") engaged under the scheme which involve recurring expenditure incurred from Consolidated Fund of the State;

NOW, THEREFORE, in exercise of the powers conferred by section 4 read with section 3 of the Gujarat Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2017 (Guj. 3 of 2017), the Government of Gujarat hereby notifies the Scheme to give subsidy on establishment of 100 Broiler unit with training of poultry farming to Scheduled caste people, with an aim of upliftment of financial and nutritional status of scheduled caste people with the following eligibility/requirement through the Director of Animal Husbandry for the benefits of **beneficiaries** namely:-

1. (1) Individuals eligible to receive benefits under the Scheme shall be required to furnish proof of possession of Aadhaar number or undergo Aadhaar authentication.
- (2) An eligible beneficiary entitled to receive benefits under the scheme, who does not possess the Aadhaar number, or not yet enrolled for Aadhaar number, but desirous of availing the benefits under the scheme shall be required to make application for Aadhaar number enrolled on or before the 31st December, 2017:

Provided that the beneficiaries is entitled to obtain Aadhaar number as per the provisions of section 3 of the aforesaid Act and such beneficiaries may visit any nearest Aadhaar enrolment Centre for enrolment.

(3) As per regulation 12 of Aadhaar (Enrolment and Update) Regulations, 2016, published by the Government of India, Director of Animal Husbandry which requires beneficiaries to undergo authentication or furnish proof of possession of Aadhaar number as a condition for receipt of any subsidy, benefit or service as per provisions of section 3 of the aforesaid Act, shall ensure enrolment of its beneficiaries who are yet to be enrolled, through appropriate measures, including co-ordination with the Registrars District/Municipal Corporation for the enrolment of Unique Identification (UID) number and setting up enrolment centres at convenient locations:

Provided that till the Aadhaar number is assigned to the beneficiary, the benefits under the scheme shall be given to such beneficiary subject to the production of the following documents, namely:-

- (a) (i) if beneficiary has enrolled his Aadhaar Enrolment ID slip, or
(ii) a copy of request made for Aadhaar enrolment, as specified in sub-para (2) of para 2 and
- (b) any of the following documents,-
 - (i) Bank Passbook with photograph,
 - (ii) Voter ID card,
 - (iii) Kishan credit card,
 - (iv) NREGA Job card,
 - (v) Driving Licence, or
 - (vi) Any other documents as may be specified by the State Government:

Provided further that the above documents shall be verified by an officer designated by the State Government for that purpose.

2. In order to provide convenient and hassle free benefits under the schemes to the beneficiaries, the State Government shall make all the required arrangement including the following, namely:-

- (1) wide publicity through the media or individual notices through the department in charge of implementation of the scheme, through the Director of Animal Husbandry, shall be given to the beneficiaries of the scheme to make them aware of the requirement of Aadhaar number under the scheme and they may be advised to get themselves enrolled at the nearest Aadhaar enrolment Centre available in their area on or before the 31st December, 2017, in case they are not already enrolled. The list of locally available enrolment Centres shall be made available to them.

(2) in case, beneficiaries of Scheme to give subsidy on establishment of 100 Broiler unit with training of poultry farming to Scheduled caste people are not able to enrol for Aadhaar number due to non-availability of enrolment Centres in the nearby vicinity, the Director of Animal Husbandry shall be required to create Aadhaar enrolment facilities at convenient locations or beneficiaries of Scheme to give subsidy on establishment of 100 Broiler unit with training of poultry farming to Scheduled caste people to register their request for Aadhaar enrolment by giving their name, address, mobile number and other details as specified in paragraph 1 (3)(a)(ii) with the Director of Animal Husbandry or through the web portal as provided for the purpose.
